The last several months have been anything but routine at Deer Lake United Church. We have weathered the resignation of Rev Tracy Fairfield, and enjoyed the temporary spiritual leadership of Rev Brian Burke. We have approved our first major deficit budget, and committed to a journey of faith to revitalize our church.

Many of us attended the Circle Way workshops held by Amanda Fenton. The workshops introduced us to a different way of meeting, listening and exploring ideas that we will be using as we consider options for the future. You will have received Dana's email announcing the appointment of Rev. Scott Swanson as our interim minister for the next two years. The Transition Team has already met with Scott a couple of times and now, with great anticipation, we await his arrival on July 1st.

To help Scott to get to know each of us, he has requested gatherings in people's homes to meet us in small groups. To that end, the Transition Team has arranged for eight gatherings. You will have received an email with the dates and times of the sessions. Please help us to kick off this crucial transition at Deer Lake by requesting a place in one of the sessions.

2017 certainly is a time of transition for Deer Lake United Church. I already hear murmurs of cautious optimism, even excitement, where I heard only doom and gloom at the beginning of the year. We have a lot of work ahead of us, but with a strong Interim Minister, a capable Transition Team, and an active and involved congregation, I'm confident that Deer Lake has a promising future ahead of it even if we don't yet know what it will look like.

# **DLUC Circle Workshops Re-cap**

In the March newsletter, I wrote about the (then) upcoming Circle Workshops that Amanda Fenton planned to take us through to learn about the Circle Way. I also mentioned that this process reminds us of the origin of how our ancestors relied upon the circle as an efficient means of gathering around a fire — for food, warmth and protection. They quickly discovered that the circle could help design a social order providing a democratic space where each person present was equal to the next. It is also allows each of us to look the other in the eye, lean in and listen, and allow all voices to be heard equally.

Well, since then many Deer Lake board members have participated in two three-hour workshops in The Circle Way. The first was hosted on April  $22^{nd}$  (Introduction to The Circle Way) and the second on May  $8^{th}$  (The Circle Way for Issues, Disagreement and Conflict). The purpose of the workshops was to:

- Discover how the circle process can help us have challenging conversations in a healthy way,
- Deepen our listening skills as well as how we say things,
- Create a space where all voices can be heard,
- Build deeper relationships within our community, and
- Align our Christian values of "welcoming and community" with how we treat each other.

The workshops included some teachings on the components of The Circle Way and the diamond of participation (pattern of divergence, emergence/groan zone and convergence). We also practiced the skills in small group circles, which allowed for rotating leadership, relationship building and hands-on practice with the circle process.

During the first workshop, the small circles focused on personal story-sharing for relationship building and to experience the deeper listening that circle evokes. During the second workshop the small circles focused on questions that explored how church is changing and not changing, to experience how circle can help us hear different perspectives and express difference with respect.

The skills and experience gained in these workshops will help us in many conversations and interactions at DLUC – board meetings, committee meetings, even one on one interactions. Talking to each other with curious, compassionate listening and intentional speaking can be of great use in all our conversations. Some participants expressed "We need to honestly and open discuss perceived problems in a non-confrontational but open and genuinely caring way," and "We must openly encourage meaningful conversations with an attitude of willingness to listen and acceptance of differing opinions."

At the end of the workshops, many participants expressed sentiments of hope, encouragement, curiosity and openness to doing things differently, with a desire to strengthen the practice of broad discussions that are inclusive of multiple voices, multitude of ideas, and energy to tackle the ideas that rise to the top.

What's next? We still have access to Amanda's skills under the original agreement that Presbytery granted us. Perhaps she will be asked to lead our whole congregation through an exercise to demonstrate how the Circle Way process can be used constructively in 'tough' conversations or perhaps the Transition Team will want to use her skills in the work they need to do in the near future.

So, while the specifics of the next steps in circle practice haven't yet been decided, you are likely to see it 'in action' in the near future. I'm looking forward to it! I hope you are too! See you in the circle!

#### **Comments on our Financial Position**

To each member of DLUC,

Our congregation has experienced a time of surprise and change over the past several months. Rev Tracy tendered her resignation and said farewell in February. We were so very fortunate to have Rev Brian Burke join us in March, and in July we will welcome our interim minister, Rev Scott Swanson.

These changes have been challenging for our congregation in many ways, but in a practical sense, they have significantly impacted our finances. Tracy received a severance package as negotiated by BC Conference. At the Annual Congregational Meeting the congregation voted to employ a half-time minister for March – May rather than use pulpit supply, which added over \$8,700 of expense and necessitated a move to a new and costlier salary structure more than one year ahead of schedule. We have arrived at mutually agreeable terms with our interim minister, who starts July 1st. All this occurred against a backdrop of low interest rates, a declining investment account balance, and a decision to minimize withdrawals from that account to keep us viable in the long term. The bottom line is that in 2017 we are facing a potential deficit of more than \$34,000.

Despite showing an operating deficit of \$10,652 at the end of March, by April 30 we were in a surplus position. Envelope donations are up, as some members have already made significant contributions beyond their normal givings. It is truly wonderful to see this response. Deep appreciation and gratitude is offered to those who have opened their wallets and hearts.

For those who may not have fully realized our financial situation, or have not yet responded to it - we encourage each of you to mindfully consider your financial commitment at this time. Some are in a position to give at a high level, some less so. But each of us plays a part, according to our ability, in helping sustain our church and carry out God's work in the world. "Each one must give as he has decided in his heart, not reluctantly or under compulsion, for God loves a cheerful giver." 2 Corinthians 9:6-7

Over the next two years, our interim minister, Rev Scott, will be assisting us with finding a new and sustainable path forward. Those two years will be financially challenging. But we have long travelled together with a collective generosity and commitment. With cheerful hearts, we can continue our journey through this challenge. If you have not already done so, please consider what gift you may make at this time.

### **Save Tax by Donating Securities**

# If you hold securities in a non-registered investment account this message is for you.

The capital gain earned on stocks. mutual funds and other investments is not taxed when the security is donated to a charity. The United Church of Canada Foundation has an arrangement that allows you to transfer a security to them to be sold. They forward the proceeds of the sale to the charity/charities you choose. You receive a tax receipt from the Foundation and avoid the tax you would pay if you sold the shares yourself. The procedure is called 'gifting securities'. It does not apply to RRSPs or TFSAs.

#### The procedure is simple

- 1. Contact Erik Lo Forte, the Program Assistant to establish a name for your 'fund'. 416-231-5931, ext. 2026; 1-866-340-8223; Fax: 416-231-3103 eloforte@united-church.ca
- 2. Print a transfer form from their web site; complete it and send it to your investment advisor.
- 3. Send a copy to Erik so he knows to expect the transfer.
- Your advisor transfers the security; the Foundation issues your tax receipt for the market value on the day of transfer.
- 5. The Foundation sells the security and sends a cheque to the charity you name.
- You advise the charity as to how you wish your contribution to be used.

#### Some things to know:

You can name more than one charity to receive the gift. At least one charity must be United Church.

The donation to each charity must be at least \$300.

Deer Lake United Church is now receiving contributions through the Foundation.

The only fee is a brokerage charge of \$9.95 to sell the shares. If you donated directly to Deer Lake's investment account, the commission to sell the security would be much higher.

#### Another way this procedure might be useful

Often individuals who don't have an investment account receive share certificates. These could be an inheritance, a gift from a grandparent, shares from when an insurance company 'de-mutualized' several years ago. Securities can only be sold inside an investment account and it is difficult to open one for only a small sale. Often the amount of capital gain is significant. The same procedure can be used thus avoiding the capital gain tax and the hassle of opening a brokerage account yourself.

This ensemble is well worth the money. They are very professional and play all over the world. Everyone will have to get on board and promote and sell tickets. You can have a chance to hear them on July 6th at 7pm at the new outdoor amphitheater at the Langley Events Centre for free.

Next year, we propose to partner with the GoGo's for an Art Sale and Shredder event. We will hire a shredding machine and invite the neighborhood to bring any important papers they wish to shred. There will be a fee per box of shredding which will take place in the parking lot. We will be advertising with the GoGo's as they advertise for their Art Sale (which will be held in our Hall) to reach a wider audience.



### **Communications Committee**

The Communications Committee was originally formed in 1998 to relieve Alice Stephenson, the church secretary at the time, of the burden of producing the Deer Lake newsletter, then called "Newsline". The committee, varying from one to three members, has produced four issues every year since then. In all that time we have missed only one regular issue and have published the occasional special edition. Members of the committee must have a strong command of the English language and be proficient with Microsoft Word. We don't write a lot of the content ourselves, though. It is provided primarily by the minister and congregation members. The committee edits and formats submissions and does the newsletter layout using a Word template.

The newsletter, renamed "Lakeshore Lines" in June 1999, was strictly a black and white affair until March 2006 when we introduced the digital edition in colour. At that time the print edition was still in black and white. Then, at the end of 2007, thanks to Mike K and Metro Printers, we published our first colour print edition. Both the print and digital editions have been

in colour ever since. At about that time, email started to be used more frequently for communicating with the Deer Lake community, and the Communications Committee assumed responsibility for maintaining the distribution lists and sending out bulk communications.

In March 2005, Chantel McB developed Deer Lake's first website. Two years later, Deer Lake got its own domain name (dluc.ca), and Chantel redeveloped the website to modernize it, align it with our vision statement, and enable the Communications Committee to modify some of the content. That website was instrumental in attracting several families to Deer Lake, but after seven years it started to show cracks and eventually became impossible to update.

It was time for something new and so, after a few months of development by Garry F, the current website was launched in January 2015. This version follows the previous design, but features more pictures and is easier to keep up-to-date. It is also designed so various people can be authorized to update select areas of the website.
