Minister's Report

One of my all-time favourite musicals is Rent. Many know its signature number "Seasons of Love." The song opens by asking, "How do you measure a year?" There are many metrics that are offered in the song. Perhaps one measures it in daylights, sunsets, midnights, cups of coffee, inches, miles, laughter, strife, in truth that she learned, in times that he cried, in bridges he burned, or the way that she died. And perhaps all of those are valid ways to measure a year, but the song proposes, "How about love?"

The 2024 strategic goal was:

Deer Lake United Church will be more spiritually open to:

- Deepening our relationship with God
- Embracing the diversity of people and ideas
- Searching out new ways of being (self, church, community, world)

When the Council created this goal, they understood this to be less of an administrative goal and more of a spiritual one that aligns to our Statement of Identity, which proclaims we are a Christian community that explores and expresses our spirituality. In some ways this goal can be measured externally with numbers and actions, but in many ways, it is through acts of love that we truly see the goal being fulfilled. Those acts of love can be difficult to capture in a report such as this.

For example, we did several significant building upgrades as we continue to try to make the building as hospitable as possible. We installed sound reduction panels in the Fellowship Hall to reduce the noise level resulting from increased attendance and hard surfaces post-2021 renovations. We updated our Lower Hall by installing new flooring, painting the walls and ceiling, and removing the kitchen downstairs to make a utility room. We also completed the Dorothy Wrigley Playroom, which was a massive overhaul of the former stage area in the Fellowship Hall. Some of this was done by outside contractors and a lot of it was done by members of Deer Lake United as an act of love for our church.

Another aspect that marked 2024 was saying goodbye to five beloved members of Deer Lake United who passed away. A lot of grief was held within our little church as three of those deaths occurred in the Fall, within two months of each other. Each of these individuals were loved dearly by our church, and saying goodbye was a difficult reality we had to accept.

On a more positive note, we ended 2024 with a surplus of funds. This was a tremendous blessing as we originally budgeted a deficit of \$32,711.00. All of our income sources received higher than budgeted amounts, including receiving \$17,391.20 additional donations through Envelope Offerings. This generosity speaks to something happening, which I want to believe is people continuing to take steps of faith out of their deep love for God and the church.

My hope is that by "reading between the lines" of this report, you will see that Deer Lake United has deepened its relationship with God, embraced one or two diverse ideas and people, and have sought out new ways of being. Is there more work to be done? Absolutely! Luckily, we have all of 2025 and beyond to continue our spiritual journey with God. And trust me, 2025 seems like a year no one will forget!

I had trouble deciding what to write in my 2024 council report, too many good things! Then.... inspiration!!

This year has been about decisions. What needs to be decided, who needs to decide, what to base these decisions on? It's been a learning curve and a thoughtful process as each month brings the opportunity to make a statement about who we are through action. To start off 2024, most of our DLUC leadership (17 of us in total from the Council and all committees) came together to share a meal and identify where we see opportunity at Deer Lake United, and how we may choose to act on it. What questions might we ask when facing a decision? We came up with these criteria questions:

- "How does this align with our statement of identity?"
- "Would this action fall within the theology of the United Church of Canada?"
- "How best can we serve God through this decision?"
- "Does this fit with our mission statement or are we trying to get our mission statement to fit into this?"

The outcome of any decision would ideally reflect who we are, what we believe, what best speaks authentically to our faith and calling from God. It's a big deal; sometimes about a very small thing. Having said that, it's an important practise and one that needs intention and repetition. We have not always been successful integrating these guiding questions for a variety of reasons such as time, energy, or memory. I am, however, so heartened to

recognise that when we have based our decisions on the criteria above, our answers have been smooth, well-thought out and almost always unanimous. This says a lot about your Council and the growth we have experienced over the past few years. We, as a Council, and generally as a church community, have become more likely than not to participate and interact with each other and our world beyond with grace, wisdom and a sense of social justice. We also recognise (more often than not) that God's in charge and has a plan for us. Hard to remember, harder to surrender to, but we're getting there.

The Council reviewed our 2024 strategic goal in a mid-year check in and all felt it was solid and serving us well. We wondered how the congregation might be relating to it and how we could encourage a greater sense of ownership from our church population. This remains a goal as we hope for more participation, more help, more commitment to group needs, and more support for each other as we turn decisions into action in so many ways. The commitment each of us made and placed in our envelopes at last year's Annual Congregational Meeting will tell a story. How did we as individuals work on the goal? What were our intentions, and what was the reality? If unsatisfactory...why?

At the end of 2024 we were left with a surplus. An amazing illustration of prudent, planned spending, and of the generosity and support of our members. The Council spent a good amount of time over several meetings discussing what to do with any money remaining after all budget items and money owed to renovation projects had been satisfied. Then we came up with a division for the remaining funds that we feel best reflects Deer Lake United's values and identity. The 2024 surplus will be dispersed in the following way: 40% will go to charity (outreach), 30% will support further programming at Deer Lake United, and 30% will be saved for future use. We will ask the attendees to weigh in on a preferred charity to receive our donation at the 2025 Annual Congregational Meeting. This year we will limit possible recipients to those organisations we presently support. This decision was the 2024 highlight for me personally. It feels right and true in so many ways. And yes, it easily satisfies the criteria questions your leadership generated at the beginning of the year.

There is always so much to think about, to address, and occasionally to wrestle with. We have been gifted with a wonderful group of Council members in 2024. I thank each of them for their service, their two meetings a month, their good-natured receipt of countless emails from me with attachments missing. Deer Lake United has been well served. We say goodbye to Trish, Jim, and Becky with great thanks and look forward to welcoming three new faces to our fold.

2025 will find us on our own for a few months as Joseph goes on his sabbatical. Decisions will need to be made, but I know this will happen thoughtfully with trust in God and in each other. I have no doubt that if we will all pitch in, any disruption will be minimal and quickly remedied. I might even say this will be a sabbatical for us as well, but Joseph might take that the wrong way!!!

It's been a smooth fulfilling year for us and hopefully for all congregation members. With thanks and anticipation for what's to come.

The Ministry and Personnel Committee (M&P) oversees employment relationships at Deer Lake United Church.

Deer Lake United Church has two regular staff members, Rev. Dr. Joseph Kyser, our minister, and Pam Athey, our administrative assistant. Joseph has again shepherded us through the year with abundant skill and care. He has shown leadership on many levels including building upgrades and maintenance, developing faith in the congregation through Sunday sermons and one-on-one support and counselling. Pam continues to be a valued employee who supports Joseph's work and the daily running of DLUC. She has shown great ability to pivot in her daily busy work life to accommodate the many logistical instances requiring attention.

We are also fortunate to have Barry Yamanouchi and Vilma Villa-Del Mundo, both of whom work on contract. Barry, our talented pianist, enriches our worship services with his musical gifts. Vilma, who does the bookkeeping, plays a vital role in keeping our financial books in order.

According to the United Church Manual, M&P's role is threefold: to offer consultation and support to the minister and other Deer Lake employees, to foster healthy relationships between staff and others at Deer Lake, and to provide supervision and oversight to staff.

Throughout 2024 M&P strove to fulfill the three aspects of its role:

- Consultation and Support: M&P members were available to provide support and advice when needed.
- Healthy Relationships: M&P attempted to keep the congregation informed about how constructive feedback can be offered and received in a positive way. M&P also worked to maintain confidentiality while being as transparent as possible.
- Supervision and oversight: Throughout 2024 M&P dealt with regular staffing matters, including job descriptions, performance reviews, and scheduling time away.

The Ministry and Personnel committee looks forward to working with Deer Lake staff in 2025.

The Trustees provide oversight to the church's assets, particularly regarding the property, insurance, and investments.

Investments

Deer Lake United Church has two investment accounts. One holds the proceeds of the sale of a manse years ago. We refer to it as the 'Primary' account. We require approval from the Pacific Mountain Region to use these funds beyond the approved annual transfer of 4% of the balance as of December 31 of the previous year. The second account was opened to hold accessible congregational money not required for our day-to-day operations to achieve a better return than in our bank account. We refer to this account as the 'Congregational' account. Funds from this account may be used, depending on the amount, with Council and/or the congregation approval. Our investment funds are held in fee-based accounts with Daniel Wong at Connor Clark and Lunn. The annual transfer from the Primary Account to the bank account was done in January 2024 in the amount of \$15,452.

Insurance

Our property and liability insurance was reviewed semi-annually. After careful consideration, Council determined that the Accidental Death and Dismemberment policy no longer added value to our insurance coverage, and it was not renewed.

Property

No significant property issues were experienced in 2024. The renovation of the Nursery was completed and the name changed to the Dorothy Wrigley Play Room. It is used weekly for meetings and small group gatherings. The flooring in the Lower Hall was replaced. This, along with maintenance changes, has made it more useful to our congregation and to renters. We also added sound reduction panels in the Fellowship Hall to ensure the noise level stays reasonable. The Trustees extend their heartfelt thanks to all the committed volunteers who maintain our building and dedicated their time and talents to our renovation projects.

The Envelope Secretary looks after the donations that are received at Deer Lake United Church through envelopes. I ensure your gifts are recorded and receipted accurately and confidentially.

We are very grateful for all the gifts received from those committed to the operation and outreach of our church. We treat each donation with respect.

A huge thank you to our team of counters who record the donations each week using envelope numbers, count the offering and deposit the donations. This team includes Bob and Karen Chapman, Garry and Gloria Forwood, Mike and Wendy Kyer and Laurie and Shirley Smith. We are most grateful for their dedication and attention to detail.

We have 99 envelope numbers attached to families or individuals, which helps us record and receipt donations. This number is down from last year due to deaths in the congregation and inactive people being removed from the list.

Of the 99, 49 families donate through their envelopes regularly and 50 families donate through PAR, pre-authorized giving's, which means a predetermined amount is taken directly from their bank account once a month and goes directly to the Deer Lake United bank account. We also have 2 families that have chosen to donate securities through the United Church of Canada Foundation. This is tax advantageous and receipts are issued from the Foundation. Financial Report

Overview

2024 was remarkably successful financially as we ended the year with a budget surplus of \$13,834! The generosity of our donors, higher than expected rental and fundraising proceeds, and lower expenses came together to overcome a budget deficit of -\$32,921. The 4% draw (\$15,452) from our Primary Investment Account was not needed to cover expenses. Our investments benefitted from the positive stock market performance. Our 4% transfer at year end will be \$17,300. A heartfelt thank you to all of you who did so much to bring about this.

Our chart of accounts has a fresh look. It is now organized to align with the governance model we changed to in 2022. Some account names were adjusted to make them more descriptive. Contract employees are now included in Wages. Technology moved to Operating Expenses. Other minor modifications were made to accommodate the transition to our new bookkeeper. These changes have disrupted the comparison with past years. As we adapt, historical data going back to 2011 can be found in past annual reports on our website.

Revenue from Local Operations

Overall, our revenue from local operations was significantly higher than we originally anticipated thanks to generosity within our congregation. Envelope offerings to local were \$11,391 more than we budgeted. Our loose offerings increased by \$240. Special contributions such as shares through the United Church Foundation increased by \$6368. Fundraisers throughout the year also aided by raising \$1729 more than we anticipated. In total, our local operations raised \$19,729 more than we budgeted for.

Rental Income

We maintained all our long-term tenants in 2024. The significant increase was from short term rentals (Increase of \$3,334) and a new rental, My Pop Choir (\$4,950).

Personnel

Our personnel expenses look different in the report this year. Our musician and our bookkeeper who are contracted are now included. The musician was formerly under Staff Relief and the bookkeeper was an office expense. Lower expenses for Pulpit Supply and Continuing Education balanced out slight increases in other accounts.

Operating Expenses

Our church operating costs were less than we anticipated (by \$10,094) due to lower Office Supplies, Other Costs, and Repairs and Maintenance expenses. However, Telephone and Internet was over by \$624. Included in the budget for Repairs and Maintenance was an update to our security system which has been deferred to 2025.

Program Expenses

Program expenses were over by \$1,532. Near year end, there was a purchase of curriculum material for Christian Education to be used in 2025 and beyond. Other program expenses were below budget. Not shown in the financial reports is the donation of a piano for the Lower Hall.

Special Projects

The upgrade of our nursery completed this year, was covered by a donation in memory of Dorothy Wrigley. The sound proofing in our Fellowship Hall received donations of \$10,576 with \$4,553 coming from savings. Replacement of the flooring in the Lower Hall received donations of \$7,900 including a donation from our day care tenant. \$12,100 came from savings. We recognize the exceptional contribution of time and talents from the committed team of workers who completed these projects. The cost saving from their efforts is beyond calculation.

Net Surplus from Operations

To finish 2024 with an excess of \$13,834 is a cause to celebrate. This was anticipated by Council in November. Recognizing that this money is intended support our Ministry, Council decided to divide the surplus into 40% for Outreach, 30% for Program and 30% to savings. These amounts have been added into the 2025 budget.

Future Outlook

We have been so fortunate and blessed by God to see increased giving and revenue streams for the past three years. We continue to be dependent on our investment accounts, which means that the financial markets need to maintain health. As I end my first term as Treasurer, I want to extend a big thank you to our financial "team": Administrative Assistant Pam Athey, envelop steward Kathy Richardson, bookkeeper Vilma Villa-Del Mundo, and Joseph. They were constantly just an email away.

DEER LAKE UNITED CHURCH NOTES TO FINANCIAL STATEMENTS FOR THE YEAR ENDING DECEMBER 31, 2024

1 Deer Lake United Church

Deer Lake United Church (the "Church" or "DLUC") is a congregation under the United Church of Canada located in central Burnaby. The Church is a not-for-profit organization and a registered charity under the Canadian Income Tax Act.

2 Significant Accounting Policies

(a) General Operating Funds

This fund is used for daily operations of the Church. Donations that have no specific instructions as to use, are added to the general operating fund, as well as rental income. The funds are used for regular Church operations such as personnel expenses, church operating expenses, and program expenses.

Designated Funds

These funds have specific instructions placed by the donors on the use of the funds. DLUC will make every effort to honour the donor's request, but is under no obligation to do so. Any surplus remaining after the project is completed or the program has ended will be transferred to the General Operating Fund. The expenditures are approved by the Treasurer to ensure it is in accordance with the donor's request.

Building & Contingency Fund

These funds have specific instructions placed by the donors on the use of the funds. DLUC will make every effort to honour the donor's request, but is under no obligation to do so. Any surplus remaining after the project is completed or the program has ended will be transferred to the General Operating Fund. These funds are used for improvements to the building, renovations, the purchase of equipment and fixtures, and for an unforeseen event.

(b) Basis of accounting

These financial statements were prepared using the accrual basis of accounting, with the exeption of recording depreciation of fixed assets.

(c) Financial Instruments

The Church reports financial assets and liabilities (cash, accounts receivable, and accounts payable) at their face value. Investments are reported at market value.

(d) Prepaid Expenses

Prepaid expenses are recorded for goods and services to be received in the next fiscal year but paid for in the current fiscal year.

(e) Capital Assets

Capital Assets consists of real property (land and building) and equipment and fixtures. Capital assets are expensed in the period purchased. Capital assets on the books have not been depreciated.

The Board is responsible for decisions to enter into a congregational property transaction. A congregational property transaction may require approval from the Pacific Mountain Regional Council (PMRC). The Trustees are responsible for holding all congregational property for the congregation as part of the United Church and for proceeding with property transactions as directed and/or approved by the PMRC.

(f) Revenue Recognition

Contributions and Rental Income are recorded as revenue in the period when received or receivable, based on appropriate evidence as to collectability.

(g) Gifts in kind

Donations of property, other than cash, are recorded at fair value when such value can be reasonably determined. Charitable tax receipts for gifts in kind will be issued when the fair value is over \$20.00.

(h) Donated Services

Many Church members offer their time and services to the Church each year. These services are offered on a volunteer basis and are thus not recorded in the financial statements.

DLUC has PMRC permission to withdraw 4% of the Dec.31 balance annually. In 2024, \$15,452 was transferred to Congregational Investment Account. The Congregational Account may be used with Council and/or congregational approval depending on how much is needed.
